Assumption of the Risk

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people. Dunbar Area Little League (DALL), with guidance from federal and local officials, has put in place recommended preventative measures to reduce the spread of COVID-19; however, DALL cannot guarantee that you or your child(ren) will not become infected. Further, participation in DALL events could increase the risk of contracting COVID-19. By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) may be exposed to or infected by COVID-19 by attending DALL events and that such exposure or infection may result in illness. I understand that the risk of becoming exposed to or infected by COVID-19 at DALL events may result from the acts and omissions of others, including, but not limited to, DALL officers, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at DALL events or participation in any DALL function ('Claims'). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless DALL, its officers, coaches, volunteers, the towns of Dunbar, Normalville, & Mill Run, owners and lessors of other premises and other representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I further agree that, should my child(ren), any member of their family or any person with whom we are known to have come in contact with test positive for COVID-19 or is otherwise suspected to have been infected, that I shall immediately remove my child(ren) and all members of my family from all participation in DALL activities or events and shall immediately report the infection or contact to a League official.
